ORDER NO.E3-601/2007(1) DATED: 15.2.2010

The following candidates who have been advised by the District Officer, Kerala Public service commission, Pathanamthitta are provisionally appointed as L.D. Clerks in Panchayat Subordinate Service, Pathanamthitta in the scale of pay of Rs.(5250-8390) under Rule 9 (a) (1) of the General Rules of Kerala State and Subordinate Service Rules 1958. The advice of the candidates are subject to Rule 3(c) of the general rules of K. S&S.S Rules 1958 subject to verification of date of birth, Qualification, Community etc. with reference to the originals produced by the candidates at the time of joining duty before the head of office concerned. They should also produce a physical fitness certificate obtained from a Medical Practitioner not below the rank of a Civil Surgeon at the time of joining duty.

The appointment of the candidates are subject to the condition that the appointment should be terminated without notice, if the government is not satisfied of their character and antecedents on subsequent verification and that they will be eligible for appointment in regular service in accordance with the rules only if their character and antecedents are found satisfactory.

The candidates are informed that in the event of their discharge from the service for want of vacancies, they have to re-register their names in the office of the District office, K.P.S.C, Pathanamthitta and get themselves re-appointed on further advice by the Public Service Commission or they may wait for their turn for re-appointment to the post in this department in case they desire to continue as probationers in the post from which they are discharged. The candidates are also informed that the application for correction of Date of Birth if any should be made within five years from the date of entry in service.

The candidates mentioned below are posted in the Panchayats noted against their names and are directed to report for duty before the Head of Office concerned with the original records mentioned.

The advice of the above candidates are subject to Rule 3 (a) of General Rules of K.S.&S.S Rule 1958.

The above candidates will be on probation for a period of two years within a continuous period of three years service from the date of joining duty. They should also pass the departmental test in MOP within the probation period. The candidates should report for duty within 15 days from the date of receipt of this order failing which the order of appointment will be treated as cancelled.

The Head of office should satisfy themselves about the identity of the candidates before allowing them to join duty. The identification certificate of the candidates are also enclosed herewith. The photograph and signature of the candidates may be verified and fact recorded by the Head of Office on the Identification Certificate itself and the same should be pasted in the Service Book of the incumbent. If there is any discrepancy the candidates should not be allowed to join duty and the fact should be reported to this office.

The Head of Office should record in the Service Book of the incumbent whether appointment is "Open Competition Turn" or "Reservation Turn".

The Head of Office concerned are directed to obtain and forward the enclosed proforma (in duplicate) duly filled in by the candidates at the time of joining duty to this office along with date of joining duty.


