Government as per G.O read as 1st above has accorded sanction for the creation of one temporary post of Accountant on Rs.8390-13270 in each Grama Panchayats, which will be filled up by promotion from Upper Division Clerks in the Department subject to the General conditions and the following special conditions, among other things.

- 1. The newly posted Accountants would be given one month induction training including hands-on-training on use of computers.
- 2. Those promoted as Accountants will be retained as Accountants for a minimum period of three years except, of course, in case of promotion.
- 3. Computerisation of PRI Accounts will be initiated along with this process.

Government also ordered that the post of Accountants will be equated to that of Head Clerk in the scale of pay of Rs.8390-13270/-.

While issuing a formal order creating the post of Accounatants in each of the 999 Grama Panchayats this office has grouped them as many groups under the heads A,B and C for administrative purpose to indicate the nature of the Accountant post created now like redesignated, upgraded, created as per the order read as 2nd paper above.

Government as per G.O read as 4th has ordered that Kerala Institute of Local Administration (KILA) with the technical support of Information Kerala Mission (IKM) will conduct a basic training programme to the Accountants before their posting/appointment, approving the course content proposed for training submitted by this office.

Accordingly as per this Office order read as 5th, the 4th batch of U.D.Clerks who have under gone first phase of Induction training are provisionally promoted and appointed as Accountant as per Rule 9(C) of KS&SSR 1958 in the scale of pay Rs.8390-13270 and posted in the Grama Panchayats noted in Col.No:II against the re designated /Upgraded/ newly created post of Accountant with immediate effect.

All the newly appointed Accountants shall abide by the duties and responsibilities of Accountant fixed by the Government as per the G.O read as 3rd above.

The Accountants promoted now shall exercise their option before the Head of office concerned as provided in Para 49 of the G.O(P)145/06/Fin dated:24.03.2006 within a period of one month. The Heads of office concerned are directed to relieve the appointees/promotees soon on receipt of this order without waiting for substitute.

In the case of Grama Panchayats where one post of U.D.Clerk stands upgraded, on the joining duty of the newly posted accountant the junior most U.D.Clerk (Service Junior) in that cadre in the respective Grama Panchayat will stand relieved of duties and he/she shall report before the concerned Deputy Director of Panchayats and await for posting orders. The Deputy Director of Panchayats in turn shall furnish a list of persons awaiting posting orders to this office at once for further orders.

The Deputy Director of Panchayats should ensure that this order is implemented within a fortnight.

The date of relief and joining duty of the incumbents will be reported to this office and to all concerned promptly by the head of office.

The order will be available in the Website of Local Self Government Department (<u>www.lsg.kerala.gov.in</u>) and the transferees/promotees/Head of office are free to use the downloaded copy for all purposes.

All the above postings will be reviewed during the General Transfer 2010 as per the transfer norms.
