The Deputy Directors of Panchayats shall ensure that the posting orders to the allottees are issued, from the Queue list against the options exercised by the employees in the order of preference to stations. All the employees are at liberty to prefer application if any case of non-compliances of General Transfer norms, direct to the notice of the Director of Panchayats in relaxation to the normal procedure of channel of correspondence through proper channel for this purpose only and the Director of Panchayats will be disposing of such cases on merit. The Director of Panchayats will also entertain such cases referred to above suomoto and orders passed.

The following L.D. Clerks noted in Col.No.I are provisionally promoted to the cadre of U.D. Clerk under Rule 31(a)(1) of KS & SSR in the Scale of Pay Rs. 6680-10790 and allotted to the Districts noted

in Col.No.II with immediate effect. The U.D. Clerks so promoted should exercise their option before the head of office concerned within one month as provided in Para.49 of G.O.(P) No. 145/2006/Fin dated: 25.03.2006. The Deputy Director of Panchayats are directed to give them suitable posting against the resultant vacancies which remained after effecting transfer and postings within a week without fail.
