ORDER NO. E1-10 /2007 DATED:12.06 .2009

As per this office Notice read as 3rd a draft list of transfer and posting of Special Grade Secretary as a part of General Transfer 2009 was published inviting objections in view of the guidelines issued by Government vide G.O. read as 1st and 2nd. The 65 objections received in response to the draft list within the time limit have been examined in detail. The Special Grade Secretary so promoted should exercise his option before the Head of office concerned as provided in Para 49 of the G.O. (P) 145/06/Fin. dated 24.03.2006 within one month.

In the order read as 4th paper above Government had ordered that employees possessing the requisite language qualification could be considered for promotion to higher post in the office situated in areas where the predominant language in Tamil or Kannada even though such officers may not eligible for promotion in the order of Seniority.

In the above circumstances the following Junior Superintendent who possess the required Tamil Language Test is provisionally promoted to the cadre of Special Grade Secretary, in the Scale of Pay of Rs. 10790-18000 on Linguistic Minority basis in Tamil as per the provision contained in the Government order read as above and Rule 9(d) of the K.S. & S.S. Rules 1959 and posted as such in the Grama Panchayat noted against his name in Col.No.II.

The appointment of Secretary will not by reason of appointment by this order treated as probationer, until normal turn of promotion comes. They will not acquire any preferential right for further promotion and appointment. They will not be eligible for further promotion on the basis of Minority Language test qualification. The officer on promotion should exercise option within one month as per Para 49 of the GO(P) 145/2006/Fin Dt.25.03.2006.

The Head of office concerned will give effect to this order forthwith and report the date of relief and joining duty of the incumbents to this office and to all concerned promptly.
