ORDER NO: E8-42792/07 DATED: 10.08.2009

Government as per G.O. read as 2nd paper directed the Director of Panchayats to revise the finalised seniority list of Secretary Grama Panchayat published vide this office order read as 1st paper in accordance with the Rule 5(3), Rule 27, Rule 31(a)(1), Rule 31(c) and Rule 31(a) of K.S..& S.S.R. and also observing all the formalities of preparing seniority list. Sri.M.S.Radhakrishnan and others challenged the Government Order by filing the WP(c)No.28465/2008 before the Hon.High Court.

In the interim order read as 3rd paper the Hon.High Court observed that "Note (3) to Rule 5 of Part II of the KS&SSR states that whenever a ratio or percentage is fixed for different methods of recruitment/appointment to a post, the number of vacancies to be filled by candidates from each method shall be decided by applying the fixed ratio or percentage to the cadre strength of the post to which recruitment is made and not to the vacancies existing at that time. Therefore, the number of vacancies available to be filled up by direct recruits has to be made with reference to the cadre strength of Secretary Grama Panchayat as on 13.02.2003, after the Kerala Panchayat Subordinate Rules, 1994 came into force, the selection process for appointment by direct recruitment was completed. It is not in dispute that when the ranked list was published on 13.02.2003, 25 direct recruits were already in Service as Secretary, Grama Panchayat.The cadre strength of Secretary Grama Panchayat is admittedly 544. Applying the ratio of 6:4, direct recruits are entitled to 218 posts while promotees are entitled to 326. The Hon'ble Court further observed that "Note (3) to Rule 5 of the KS&SSR does not deal with

the manner in which the inter se seniority between direct recruits and promotees is to be determined, the rule governing seniority where the method of appointment to the same category of post in a department is by promotion and direct recruitment, is the one contained in the third proviso to Rule 27 (a) Part II of the K.S.&SSR. The inter se seniority between direct recruits and promotees will have to be decided applying the third proviso. The Director placed all the promotees above the direct recruits. That was palpably wrong and the Government was right in holding that the method adopted was wrong. However, the Government when it issued the impugned order did not direct in what manner the seniority list should be prepared. How and in what manner, the vacancies should be apportioned between direct recruits and promotees is illustrated in the third proviso to Rule 27 (a). The Government have not in the impugned order referred to this aspect. Instead, the Government have directed the Director of Panchayats to go by Rule 27". The Hon.High Court also directed the Director of Panchayats to prepare the seniority list of Secretary Grama Panchayat in the manner indicated in the third proviso to Rule 27 (a) Part II of the K.S.&SSR. The Director shall "draw up a provisional seniority list in the manner indicated in the third proviso in Rule 27 (a) Part II of the K.S.&SSR, publish the same, invite objections and thereafter finalise it after affording the direct recruits/promotees an opportunity to object to their rank" in the seniority list".

In obedience to the direction of the Hon'ble High Court, efforts were made to prepare a provisional seniority list of Secretary Grama Panchayat pursuing the manner in 3rd Proviso to Rule 27 (a) of KS &SSR but could not proceed further as there arose a practical difficulty in regularising the appointment of Departmental hands and direct recruitees by placing them in the appropriate positions in the seniority list. The matter was taken up with Government seeking further instructions in the preparation of provisional seniority list.

However in order to implement the interim order of the Hon.High Court in the stipulated time limit a Provisional seniority list of secretary Grama Panchayat was published vide this office Notice read as 4th paper inviting claims/objections. A time limit of 15 days was allowed to file claims/objections. In response to the notice 86 claims/objections were received within the time limit. All the persons who filed the objections were granted an opportunity to be heard. Out of the 86 objections were filed only 46 persons turned up for personal hearing

on 27.06.2009. All the 86 objections and argument notes put forth by the persons who attended the personal hearing have been thoroughly examined in detail.

The summary of the claims and objections filed by all the 86 persons can be categorised into as many groups as recorded below.

The persons who are included in the list appended to this order as category A contended that the provisional list may be finalised by eliminating all the promotees in excess of and above their quota continuing in the cadre of Secretary Grama Panchayat as on 13.2,2003.

The persons who are included in the list appended to this order as category B argued that their position in the existing seniority list be retained without any alteration as will be seen in the seniority list published as per order No.E8-5330/06 Dated.06.10.2006.

While a group of persons who form part of the list appended to this order as category C argued among other things that the provisional list is to be finalised only after settling their complaints regarding their assignment of seniority in the feeder category posts and changes made accordingly in the provisional list.

The persons whose names are shown in the list which is appended to this order as category D have explicitly expressed their happiness over the assigned positions in the provisional list published now but surprisingly objected to the consequential alterations or amendments without being heard in person.

Sri.C.K.Rajendran, the lone objector in the category grouped as E filed a detailed statement elaborating many points in support of his claim, pleaded that,

i) When the first batch of direct recruits was advised by the PSC only 326 promotees were eligible to hold the post of Secretary Grama Panchayat as

against the 60% quota of 544 secretary Grama Panchayat. Instead 93 secretaries in the seniority list from 21.10.93 were holding the post on 25.3.2003 and in the draft list, further 326 secretaries as on 25.3.2003 are seen included. This is against the rules. Hence the proposed regularisation of promotion of provisional promotees from Sl.No.261 to 355 in the provisional list is illegal.

- ii) In 1994, 4 vacancies were reported to PSC for filling them with candidates directly recruited through special recruitement. On 1.11.02., 4 candidates belonged to this category were advised and appointed. But regularistion of their appointments and seniority are combined with direct recruits of 5/03 and they are included in the quota set apart for direct recruits in the provisional list. This is against rules of regularization.
- iii) As on 25.3.2003 only 2 direct recruitees previously recruited were in position. It mandates regularization of appointment of 216 direct recruitees according to their date of advice immediately after the 326 promotees as per Note(3) under Rule 5 of KS&SSR.
- iv) Those Executive Officers Grade II and are not included in the special Rules and were later absorbed as Secretary Grama Panchayat remained in that category as on 25.3.2003 cannot be included in the ratio of direct recruits under the Special Rules.
- v) The seniority list of both Secretary Grama Panchayat and Junior Superintendents may be prepared simultaneously by effecting corresponding changes in the list of secretaries whenever promotion of secretaries to the post of Junior Superintendent is effected.

The list appended to this order shown as category F contains the name of persons who filed a batch of very casual objections in variant nature such as correction of name, date of

birth, necessary inclusion, regularization of their assigned position in the provisional seniority list etc.

The claims and objections raised as summarised at the forgoing paras have been thoroughly examined with special reference to the legal positions, documents adduced Government circulars cited and the following findings are arrived at accordingly.

The claims in category A on examination are found to be tenable and hence accepted on merit.

The averments put forth by the persons included in category B were examined in the light of Rule 27(a) 3rd Proviso of KS&SSR and connected other Rules and orders in this regard. On examination it is found that only 326 promotees can claim regularisation as on 13.2.2003. The remaining provisional promotees can be regularised only with effect from the date of occurrence of subsequent vaccancies in the aforesaid 326 regularised secretaries move out from that position by promotion to higher cadres or retirement etc. Therefore their objections are not sustainable and deserves no merit.

The objections grouped as category C are related to the reassignment of seniority positions in their feeder Categories under challenge in various WP(C)'s before the Hon'ble High Court and under the consideration of the Govt. As of now if their claims are entertained at this stage it will be construed to be a premature administrative decision. Moreover, on the disposal of the pending cases before the respective authorities they will have an opportunity to contest their cases separately. At this juncture such claims and objections are not taken into consideration on merit.

A perusal of the statements filed by a section of objectors grouped as D brings to light that they are totally apprehensive of the preparation of a final list to be published by this office while acknowledging their agreement to the assigned positions in the provisional list. But an objection or claim cannot be considered on conditional basis taking into consideration and foreseeing the possible alteration or changes that may occur in the preparation of a final list. As of now this office is finalising the provisional list already published based on the factual materials available and without prejudice to the contents of a seniority list that would be prepared after the finalization of the provisional seniority list. The contenders will be free to

avail themselves of opportunities to be heard at that point of time, as per Rules. Hence the claims and objections are otherwise premature in nature.

The arguments summarised as Category E have been examined with connected records. As regards his claim for the regularisation of 326 Secretaries as on 25.3.03 is Regarding his claim that the candidates under Special genuine and hence accepted. Recruitment not to be included in the Direct Recruitment quota cannot be accepted as the candidates under Special Recruitment also form part of the quota that is 40% earmarked for direct recruitments virtually. The question that there were only 2 direct recruitees in position on 25.03.2003 does not arise in the context that the Government in their G.O(Rt)No.3277/08/LSGD dated:03.09.2008and the Hon'ble High Court in the interim order in WP(C)No.28465/08 have given a certain answer regarding the status or position of direct recruits as on 25.03.2003. Hence the contention is ruled out. Moreover the question of the status regarding the number of direct recruited Secretaries as on 25.3.03, even if the vacancies claimed to have been existed were notified Sri.C.K.Rajendran could not have been accommodated as his claims is a matter finally settled by the Hon'ble High Court in various decisions including the interim Order in W.P(c) No. 28465/08 and has no relevance at this point of time. It will also be seen that Sri.C.K.Rajendran was advised only on 11.10.2004vide Lr.No.RIA(2) 5436/03/GW of KPSC as a 7th batch of Secretary, Grama Panchayats advised by KPSC against the vacancy reported by this office to maintain the quota earmarked to provide Direct Recruitees. Even if there had been sufficient vacancies open Sri.C.K.Rajendran could not have been appointed in the reported vacancies as he being a rank holder in the select list published by PSC late on 13.2.2003. Hence his claims deserves no consideration.

On going through his 4th claim it is found that those Executive Officers Grade II who were later absorbed as Secretary Grama Panchayat were recruited as E.O.Gr.II through PSC in the ratio 5:4 and 10% quota filled up by promoting LDCs in the erstwhile Panchayat Department. Therefore all the persons recruited through PSC in the ratio 5:4 as E.O.Gr.II and later absorbed as secretary Grama Panchayat after the pronouncement of Special Rules are to be treated as Direct Recruitees on par with the new recruitees is tenable. On examination of his 5th and final claim it can be seen that the seniority list of two categories such as Secretary Grama Panchayat and Junior Superintendent is to be prepared simultaneously is not practicable

since the question of regular promotion to higher cadres arises only after the finalisation of the seniority list in the feeder category.

Category F objections have been examined with relevant documents and those which found genuine are accepted.

Necessary changes are also made in the list accordingly.

In the above observations and conclusions the provisional seniority list prepared and published as per notice read as 4th paper is hereby finalised.

Thus the interim direction of the Hon. High Court in WP(c) No28465/08 dated.16.12.2008 is fully complied with.
