The following candidates who have been advised by the District Officer, Kerala Public service commission, Pathanamthitta are provisionally appointed as L.D. Clerks in Panchayat Subordinate Service, Pathanamthitta in the scale of pay of Rs. (5250-8390) under Rule 9 (a) (1) of the General Rules of Kerala State and Subordinate Service Rules 1958. The advice of the candidates are subject to Rule 3(c) of the general rules of K.S&S.S. Rules 1958 subject to verification of date of birth, Qualification, Community etc. with reference to the originals produced by the candidates at the time of joining duty before the head of office concerned. They should also produce a physical fitness certificate obtained from a Medical Practitioner not below the rank of a Civil Surgeon at the time of joining duty.

The appointment of the candidates are subject to the condition that the appointment should be terminated without notice, if the government is not satisfied of their character and antecedents on subsequent verification and that they will be eligible for appointment in regular service in accordance with the rules only if their character and antecedents are found satisfactory.

The candidates are informed that in the event of their discharge from the service for want of vacancies, they have to re-register their names in the office of the District office, K.P.S.C, Pathanamthitta and get themselves re-appointed on further advice by the Public Service Commission or they may wait for their turn for re-appointment to the post in this department in case they desire to continue as probationers in the post from which they are discharged. The candidates are also informed that the application for correction of Date of Birth if any should be made within five years from the date of entry in service.
