The following documents in original should be produced at the time of joining duty before the head of office concerned.

- 1. Certificate proving Age and Date of Birth
- 2. Certificate proving educational qualifications
- 3. Medical certificate, as prescribed in G.O(p)No.20/2011/P&ARD dated. 30.6.2011, from Medical Officer, not below the rank of an Asst.Surgeon
- 4. Original Community certificate in respect of the candidate with the Sl.No. 3, 9, 23, 27, 37, & 54 and Original Non-Creamy Layer Certificate in respect of Sl.No. 4, 7, 10, 11, 12, 13, 24, 25, 26, 29, 33, 35, 40, 45, 46, 47, 52, 53, & 55.

The appointment will be regularised only after verification of character and antecedents of the candidates and obtaining a verification certificate from Kerala Public Service Commission. Call the Candidate shall be on probation from the date of joining duty for a period of two years of duty within a continues period of three years in this department. Candidate should pass MOP test within the period of probation. Candidate should enroll in KPEPF, GIS, SLI. within one year of joining duty.

The application for correction of date of birth if any required (in bonafied case only) shall be made within five years of their entry in service (Vide GO cited – I) The verification proforma

(available in ddpkkdblog.spot) duly filled up by the candidate should be returned to this office by the head of office concerned.

The heads of office concerned should satisfy themselves about the identity of the candidates. The document proving age and date of birth, qualifications and photograph and signature of the candidate in the identity certificate should be verified before admitting them for joining duty. The Medical Fitness certificate should also be obtained in original from the candidate before admitting them for joining duty.

The Service Book of the candidate should be opened within a week from the date of joining duty and the relevant pages of Service Book of the incumbent, attested by the head of office, should be forwarded to this office for verification of Kerala Public Service Commission. It is necessary for regularisation of appointment of the candidate.

The stations in which the candidates appointed are liable to change under the norms of General Transfer in this department.

All the candidates who joined in the Govt. service on or after 1.4.2013 will be under the contributory pension scheme as per the Government Order read as VI th paper above.
