All the above postings ordered now are also reviewed as per subject to G.O.(Ms) No. 105/2007/LSGD dated: 04.04.2007.

The officers promoted now will be relieved of duties from the present station only on the joining duty of their substitutes.

Considering the exigency of services in relation to the process of General Election 2010 to Local Self Government Institutions the joining time of officers, who are under the orders of promotion and posting, shall be reduced to actual joining time only as per under Rule 127 KSR Part I.
