As per the Order read (6) above it has been decided to fill all the existing vacancies of all the categories of posts namely Special Grade Secretary, Junior Superintendent, Secretary Grama Panchayat, Head Clerk, Accountant and U.D.Clerks except Senior Superintendent in provisional promotions invoking the provision under Rule 31 (a) (i) of Kerala Subordinate Service Rules 1958 taking into account of the uncertain situations resulted in the occurrence of a large number of vacancies of various posts in this Department and the emergent situations emerged out of it to fill up the vacancies in Public interest. Therefore the following promotions are issued subject to the finalisation of Seniority/Gradation list published as per Order No:E8-28/2010 dated:09.04.2010 of Director of Panchayats in obedience to the Direction of the Hon.Supreme Court in Civil Appeal No:595/03 , 596/03 , 597/03 , 598/03 and Govt. letter No:74233/EPB1/09/LSGD dated:28.12.2009.

The following Junior Superintendent noted in Col.No.I is provisionally promoted to the cadre of Special Grade Secretary as per Rule 31(a)(1) of KS & SSR 1958 in the Scale of Pay Rs.10790-18000 and posted in the Grama Panchayat noted in Col.No.II with immediate effect.

The Special Grade Secretary so promoted should exercise his option before the Head of office concerned as provided in Para 49 of the G.O. (P) 145/06/Fin. dated 24.03.2006 within one month.

In the order read as 4th paper above Government had ordered that employees possessing the requisite language qualification could be considered for promotion to higher post in the office situated in areas where the predominant language is Tamil or Kannada even though such officers may not be eligible for promotion in the order of Seniority.

In the above circumstances the following Junior Superintendents who possess the required Tamil Language Test is provisionally promoted to the cadre of Special Grade Secretary, in the Scale of Pay of Rs. 10790-18000 on Linguistic Minority basis in Tamil as per the provision contained in the Government order read as above and Rule 9(d) of the K.S. & S.S. Rules 1959 and posted as such in the Grama Panchayat noted against their names in Col.No.II.

All the promotions ordered above are purely provisional and the rank and seniority of the officers included in this order shall be subject to change in accordance with the finalisation of the Seniority/Gradation lists published as per Order No:E8-28/2010 dated: 09.04.2010 of Director of Panchayats in obedience to the Direction of the Hon.Supreme Court in Civil Appeal No:595/03, 596/03, 597/03, 598/03 and Govt. letter No:74233/EPB1/09/LSGD dated:28.12.2009.

The Special Grade Secretaries so promoted should exercise their option before the Head of office concerned as provided in Para 49 of the G.O. (P) 145/06/Fin. dated 24.03.2006 within one month.

All the above provisional promotions ordered now are subject to the result of the WP(C) No:13396/2010 (Y), WP(C) 13395/2010 (Y), WP(C)15034/2010 (D), WP(C) 14057/2010 (F), WP(C) 13995/2010 and WP(C) 15034/2010 (D) pending before the Hon'ble High Court of Kerala.

All the above postings ordered now are also subject to **review** as per G.O.(Ms) No. 105/2007/LSGD dated: 04.04.2007.

The officers promoted now will be relieved of duties from the present station only on the joining duty of their substitutes.

Considering the exigency of services in relation to the process of General Election 2010 to Local Self Government Institutions the joining time of officers, who are under the orders of promotion and posting, shall be reduced to actual joining time only as per under Rule 127 KSR Part I.

The Head of office concerned will give effect to this order forthwith and report the date of relief and joining duty of the incumbents to this office and to all concerned promptly.

The Deputy Director of Panchayats shall personally ensure the implementation of this order.
