In compliance with the Judgment in Civil Appeal No.595/03 to 598/03 dated: 24.11.2009 of the Hon.Supreme Court, this office published a final seniority/gradation list of all categories as per order read as 4th above. As per the Government Order read as 5th above the posts of Special Grade Secretary and Senior Superintendent in Panchayat Department are merged into one category and the post is redesignated as Special Grade Secretary/Senior Superintendent/Performance Audit Supervisor .

The interim order dated: 16.06.2010 staying the promotion to the cadre of Senior Superintendent in the WP© No:13850/2010 was vacated by the Hon.High Court by an interim order in IA No.17126/2010 in WP©13850/2010 on 13.12.2010 making clear that, any promotions made would be subject, to the result of the Writ Petition.

The 66 posts of Performance Audit Supervisors have been lying vacant quite for sometime resulting in the non functioning of Performance Audit System in the Grama Panchayats.

Hence there has been an urgent administrative necessity to fill up all the vacancies of Performance Audit Supervisor. Consequent on the merger of Special Grade Secretary and Senior Superintendent in the department the post of Junior Superintendent has become the feeder category of Special Grade Secretary/Senior Superintendent/ Performance Audit Supervisor. At

this stage it is felt administratively difficult to prepare the select list of Senior Superintendents after following a series of formalities in connection with the convening of Departmental Promotion Committee.

This office submitted a provisional select list of 76 senior most Junior Superintendent to be considered for promotion to the post of Special Grade Secretary/Senior Superintendent/Performance Audit Supervisor to Government requesting permission to effect promotion in this regard. The Government as per letter read as 7th above have accorded permission to effect provisional promotions of 76 Junior Superintendents under Rule 31 (a)(i) of KS&SSR 1956 relaxing the government restrictions on provisional promotions.

Meanwhile 20 posts of Special Grade Secretaries, who are working as Special Officers or functioning as Municipal Secretaries in the erstwhile Grama Panchayats are being replaced by the regular hands from Department of Urban Affairs. The promotion of 4 Special Grade Secretaries who are working in 4 Linguistic Minority Grama Panchayats is being regularised and allowed to continue. Therefore there is every need to accommodate the 20 Special Grade Secretaries also in the departmental cadre limiting the total number of persons to be promoted to the post of Special Grade Secretaries to 60 for which sanction has already been accorded.

Therefore, the following 60 Junior Superintendents noted in Col.No.I are provisionally promoted to the cadre of Special Grade Secretary as per Rule 31(a)(1) of KS & SSR 1958 in the Scale of Pay Rs.10790-18000 subject to the result of the WP(C)13850/2010 and posted in the Grama Panchayats noted in Col.No.III with immediate effect.
