The Deputy Director of Panchayats concerned are directed to give effect to this order on or before 28.01.2008 and report of transfer of charges should be sent to all concerned promptly. The date of relief and joining duty of the incumbents should also be sent to all concerned.

The officers so promoted and posted in the offices within their native district will have no future claim to continue in the stations by virtue of promotion if their seniors are working in the stations out side the district.
