**ORDER No. E8 - 1/2007. Dated: 22.12.2007.**

The following Head Clerk noted in Column No. I are provisionally promoted to the cadre of Grama Panchayat Secretaries in the Scale of Rs. 9190-15510 under rule 31 (a) (1) of KS & SS Rule 1958 and posted in the Grama Panchayat noted against their names in Col. No. II with immediate effect. They are promoted purely on temporary basis and they shall not have any right over the post to which they are promoted and will be reverted as soon as PSC hands join duty. A separate order will be issued to regularise the temporary promotees. In respect of persons who are provisionally promoted as per the order read as 1<sup>st</sup> and 2nd paper above, separate orders will be issued regularizing their promotion.

The officers on promotion should exercise option within one month as per Para.49 of the G.O.(P) 145/2006 dated: 25.03.2006.
